

- 1. Membership and jetty fees run from 1st January to 31st December. Members are not permitted to use jetty & slipway unless both fees are paid. Fees are due by 1st March latest.
- 2. A jetty space is for one vessel only. It is not permitted to stack a second vessel on top of another. This includes kayak, canoe or RIB.
- 3. In order to maximise space and reduce loading on the jetty, road trailers cannot be stored on the jetty. Exception will apply if your road trailer is also your only launching trolley.
- 4. The jetty is for members' use only, with the exception of visiting yachtsmen/dinghy sailors from other clubs.
- 5. Boat owners must have insurance cover.
- 6. Any member who does not sail regularly and is currently occupying a jetty space may be asked to remove their boat during or after the sailing season (irrespective of any fees paid) to make way for a member who sails regularly. No member shall use the jetty as long-term storage for their boats or other property.
- 7. All persons using the jetty and facilities do so at their own risk.
- 8. Motor vehicles including scooters are not permitted on the jetty.
- 9. Boats must be securely tied down when not in use. Only rope, not wire, may be used for the tie-down strops. It is recommended to secure your vessel with a padlock or combination lock. If you do so, you must give the Bosun a key to the padlock or advise the combination number.
- 10. Buoyancy aids must be worn when on the water plus launching or recovering a boat.
- 11. The club cannot accept any responsibility for members' property stored on a boat or in the boathouse, including any acts of vandalism, damage or theft of equipment.
- 12. Diving or fishing from the jetty or slipway is not permitted.
- 13. Members have the authority to ask trespassers to leave the jetty or slipway.
- 14. Any child under 18 years of age must be under parent supervision.

- 15. Users of the jetty/slipway should do so with consideration to other members and visitors.
- 16. If painting or varnishing a boat on the jetty, suitable protection for the decking must be used. Should any spillages occur they should be cleaned up immediately and reported to the Bosun.
- 17. Smoking is not permitted in the boathouse or container.
- 18. Any craft unrecognised as that of club member or visitor will be removed.
- 19. The key code for the gate must not be given to non-members.
- 20. If the hosepipe is used, please ensure the wall mounted tap is turned off after use. The hosepipe should be properly stowed after use.
- 21. Wall racking in the boathouse may <u>only</u> be used to store sail bags, centreboards and rudders/tillers, no personal clothing. Any other unidentified item which appears will be given a dated red tag and if the owner has not removed the item after one month then that item will be removed and disposed of.
- 22. For security purposes, when opening the combination lock on the main gate please spin the numbers when you have attached it back on the clasp. Also remember to spin the numbers once you have closed the gate on leaving.
